HARB RMASTER REP RT

Thank you to all FLHPOA harbor members who took the time to complete the **2022–23 harbor survey** and give the harbor committee some great direction and ideas to focus on. All your voices have been heard and all comments have been reviewed and considered. The committee is currently meeting monthly to make sure the right repairs, improvements, and ideas are moving forward.

A reporting system is now in place on the Harbor page of the website (https://foxlakehills.org/parks-harbor/harbor/) to make it easy for all residents to report suspicious activity, crashes, incidents, missing items, etc. All incident reporting for both Chesney and Bayview are online and are emailed out to all the harbormasters to investigate. This will help timestamp the occurrence, ask the right investigative questions, and give you the option to have us pull video surveillance.

All expenditure details can be found on the FLHPOA Harbor Fund accounting report, which is shared at our monthly meetings. Please join us sometimes to hear about what the board is doing to continually improve your community, parks, beaches, and harbor. The meetings are always the 3rd Wednesday of every month and all residents are encouraged to attend.

Be sure to mark your calendars for the FLHPOA In-Person Harbor Registration Event on Sunday, March 5 from 1pm to 3pm at the Lake Villa Township Community Center. See the next page for more information.

Want to bypass the in-person harbor registration event? Try Early Bird Registration and schedule a 1-on-1 meeting with one of the FLHPOA harbormasters and avoid the March 5th event completely.

We waived the **inconvenience fee** for the harbor the last 2 years due to the pandemic, but we are reinstating the fee in 2023. A \$50 inconvenience fee will be charged to all registrations after the March 5th in-person event. So, make sure you either early-bird register or attend the main event.

We are all looking forward to another great boating season and making sure our harbor is the best on the Chain O'Lakes for our residents!

Harbor Registration



IN-PERSON HARBOR REGISTRATION EVENT: Sunday, March 5 From 1pm To 3pm Lake Villa Township Community Center (37850 Rte. 59)

All new and existing FLHPOA harbor members need to pre-register online. If you have questions, please contact Steven Jergensen at (224) 444-9541 or email (flhpoa.bayview.harbor@gmail.com).

- STEP 1 Pre-register online NOW at https://foxlakehills.org/meetings-events/harbor-registration/ The deadline to pre-register is March 5th. *NOTE: Online registration is REQUIRED in advance.* If you do NOT pre-register by the deadline, you may lose your slip even if you show up to the in-person event on the 5th.
- STEP 2 Gather your verification documents (copy of current watercraft registration, copy of active watercraft insurance, and PAID receipt of your 2023 HOA dues) from the pre-registration. These documents will need to be shown at either the March 5th event or an early-bird meeting with a harbormaster to complete your registration.
- STEP 3 Print out the "Harbor Rules and Regulations" document from the bottom of the Harbor Registration page on the website. Sign, date, and have ready to turn in on March 5th or at an early-bird meeting with a harbormaster.
- STEP 4 (This step is NOT required for scheduled early-bird registrations) Line up between 1pm and 3pm on March 5th at the in-person event and one of our volunteers will verify your documents, collect your signed Harbor Rules and Regulations, collect payment, and either hand you your keys/slip # or add you to a waiting list (if you are new to the harbor or rejoining us after a break).

NOTE: The EARLY BIRD 1-on-1 schedules will be released in January via the website and email after we receive the keys and permit stickers from our vendors.

ARE YOU FEELING THE SQUEEZE OF HIGHER UTILITY BILLS?

Try these suggestions from familyhandyman.com...

- Replace worn-out weatherstripping around doors
- Adjust your door threshold or install a door sweep
- Locate window leaks & seal them with caulk
- Use heat-shrink plastic window film
- Consider using thicker curtains or dual-cell honeycomb shades & keep them closed at night
- Open window coverings when the sun is out
- Insulate & seal air leaks in attics/crawl spaces
- Close your fireplace damper <u>when it's not in use</u>
- Fill gaps around electrical outlets & switches
- Clean refrigerator coils & check temperature (38-40°)
- Drain your water heater & decrease the temperature
- Insulate your water heater & exposed water pipes
- Take shorter showers & use cold water to wash clothes
- Keep your dryer duct clean
- Switch to a thermostat that can be scheduled to reduce temperatures at night and/or while away
- Change your furnace filter regularly
- Plug electronics into a power strip & turn off the power strip when not in use

DO YOU HAVE A WINTER SAFETY KIT?

According to the American Red Cross, an emergency kit should contain:

- One gallon of water per person per day, up to a 2-week supply
- A 2-week supply of easy-to-prepare, non-perishable food
- First aid kit
- 7-day supply of medications
- Sanitation and personal hygiene items
- Emergency blanket
- Multi-purpose tool or toolkit
- Flashlights
- Extra batteries
- Cell phone with chargers
- Battery- or crank-powered radio
- Cash
- Family and emergency contact info
- Copies of personal documents (e.g., medical information and list of medications, birth certificates, proof of address, insurance policies)




Orchard Park will be getting new PLAYGROUND EQUIPMENT this spring!


